



## 2018 Event Vendor Concession Contract

The parties to this contract are Muddy Mamas (a.k.a. Girls Inc. of Washington County and Girls On the Run of Washington County) (hereafter "Host") and \_\_\_\_\_ (hereafter "Vendor").

Whereas, Host is hosting an Event known as Muddy Mamas to occur at Washington County Ag Center on **09/15/2018**, beginning at **7:00** am, and has the right to license concessions to vend at and during the Event, and

Whereas, Vendor desires to vend \_\_\_\_\_ at and during said Event

The parties agree as follows:

1. The Host reserves the right to accept or reject each application.
2. Food Vendors must provide a menu and shall not vend any goods or services other than those described, at and during the Event without the Host's written consent.
3. Food Vendors will need a WASHINGTON COUNTY HEALTH DEPT. PERMIT
4. Duplicate vendors will not be permitted
5. Vendor shall have access to the location beginning at 7:00 a.m. to set up. Vendors can be set up at 7 a.m. but NO LATER than 8:30 a.m. All vendor parking must be completed by 9 a.m. At conclusion of the event at **3:00 p.m.**, vendors will have 2 hours to dismantle and remove all things brought to the location by Vendor. Vendor shall leave the location clean of trash and substantially in the condition it was before Vendor occupied it.
6. Vendor's vending station shall be clean and orderly; and shall comply with all applicable laws and regulations.
7. Vendor's staff may announce the availability of the goods to be vended only while they are within the confines of the vendor's location.
8. Vendor's staff shall be clothed and groomed in a clean, neat fashion and shall conduct themselves in an orderly fashion.
9. No loud music, noise, or sound amplification devices shall be used by vendor's staff at the location.
10. Vendor hereby agrees to follow all applicable laws and regulations of the County and State of said event.
11. Vendor payments are non-refundable. The event is rain or shine.
12. Vendor hereby agrees to indemnify and hold harmless the Host against any damages or claims that may arise in connection with Vendor's presence at the Event and Vendor's activities of any kind.
13. No tents, tables or chairs will be provided. Please bring your own.
14. Non-Profits must provide tax exempt status
